## **Isanti County Fairgrounds Winter Storage Policy 2009 - 2010**

Attached commitment form must be returned with your full payment by August 1, 2009 to reserve a space for this fall.

- All winter storage rates will follow rate guidelines. Any negotiations that vary from the standard rental rates or policy will require fairboard approval.
- Please disconnect battery in all units. The Isanti County Ag Society asks that a piece of cardboard be provided for under the drive train, if possible.
- It is the owner's responsibility to provide your own insurance and releases any and all claims against the Isanti County Agricultural Society for any damages, vandalism, malicious mischief or theft that may occur. Last units parked will be required to be first out. Owners will be contacted by phone starting April 1<sup>st</sup>.
- Storage items may be brought in by appointment after September 15, 2009 and must be removed no later than May 1, 2010. Isanti County Agricultural Society reserves the right to remove stored item from rented space after that date at the tenant's risk and expense, if necessary.
- Jet Ski's & Motorcycles will be used to fill space for \$75.
- Will give credit for breakaway hitches.
